We will use the <u>Vegetable Gardening Handbook for Beginners</u> created by the Los Angeles County Master Gardeners, University of California Cooperative Extension and the <u>Southern California Native Plant Guide</u> developed by Tree People as our primary reference books. # **COURSE OVERVIEW AND OBJECTIVES**

## **Class summary and goals:**

The FEAST Garden Practicum is a hands-on introductory class designed for students with an interest in learning about and applying sustainable agriculture and lanscape techniques. Students will gain a deeper understanding of agricultural management and small-scale farming. With leadership provided by the FEAST Faculty Advisor and FEAST Student Managers, students will engage in seasonal farming activities with a focus on edible and medicinal plants, native habitat and pollinator gardens, resource and water management, chicken stewardship, the basics of soil health and compost, as well as how to organize and host community events. Graded on a Credit/No Credit basis only.

# **Course Objectives and Learning Outcomes:**

The objective of this course is to utilize Occidental's FEAST gardens as a living laboratory, offering real-world opportunities for observation, skill-building, and stewardship. At the end of this course, students will better understand plant and animal lifecycles, habitats, soils, climate, and resource management.

## **Class structure and format**:

Each student will devote 2-3 learning hours a week to a specific FEAST project with a FEAST garden team. The three FEAST garden teams are the Bruce Steele Garden Team which includes Chicken care, Native Garden Restoration Team and Cafeteria to Compost Team. Teams will be self chosen based on interest and availability. The Instructor or FEAST Director will sign off on your learning hours. You may work on multiple teams.

As a class, we will meet during the semester to check in and give updates on specific FEAST projects and learning hours.

Occasionally, Oxy will host related guest speakers or workshops that can be attended in lieu of some weekly learning hours but will need to be approved ahead of time by the instructor. For example when the local non profit, LA Compost, conducts a compost workshop, you may attend it to count towards your weekly hourly minimum.

<u>Class expectations</u>: As a credit/no credit course, participation in UEP 120 is key. You are expected to show up to your scheduled learning hours on time and ready to get your hands dirty! This means wearing appropriate clothing for the garden such as closed toe shoes, clothes that you don't mind getting dirty, and sun protection such a hat, long sleeves, and/or sunscreen. I also encourage you to bring a water bottle on hot days.

# ASSESSMENT AND GRADING

UEP 120 is a 1-unit course. It is expected that students in this class on average will devote at least two to four (2-4) learning hours a week to class activities (including in-class meeting time). You must complete 25-40 leaning hours this semester to pass this class.

\*Note — If you miss your scheduled time you will first need to notify your FEAST team leader so they can plan accordingly and you can make up the learning hours the following week. I will also offer extra credit assignments throughout the semester for additional opportunities to earn hours.
