Agreement to Participate (Part III):

1. ACKNOWLEDGEMENT AND ASSUMPTION OF RISK: I have read and agree to the following terms. (*)

SEMESTER ABROAD participants are billed a flat fee equivalent to Occidental tuition, plus standard double room, meal plan B and insurance charges (see INSURANCE, above) unless explicitly described otherwise in program materials. IPO pays tuition (and usually room and board) directly to international partners. For meals not provided by the program, IPO issues a meal stipend based on pre-established, in-country student meal calculations.

FACULTY-LED COURSE participants are billed regular tuition (for the on-campus component) plus the published program fee.

ALL participants personally pay the following expenses: international airfare; the cost of obtaining a passport; all required visas; all personal expenses; published fees for late paperwork or withdrawal.

Participants who cancel after the date specified including partial participation in the Program (including but not limited to conduct violations resulting in expulsion or medical withdrawal), are still responsible for the entire cost of the Program and have no right whatsoever to receive a refund. Leaving the program voluntarily or involuntarily (see TERMINATION, below) does not diminish or affect financial obligation.

4. IMMUNIZATIONS: I have read and agree to the following terms. (*)

I acknowledge that certain inoculations and immunizations may be recommended or required, and that I am responsible for obtaining these. I accept that Occidental College shall not be liable for any failure on my part to heed to such recommendations.
